Governance and Responsibility

Regents will be issuing requests to the appropriate chief administrative officers of the respective management boards, institutions, or other appropriate bodies to appoint an available representative to the LMC for a two-year term starting January 1, 2023. With this action, we seek to confirm half of the 18 seats in the LMC. Also, the Commissioner will ask to appoint the Chief Scientist, Technology, and Economic Advisor to the LMC for a two-year term.

The Executive Director makes a motion to hold a review of the by-laws including any proposed changes in conjunction with the August meeting. The governance review will take on August 23rd from 1 to 2:30pm followed by a regular meeting from 2:30 to 3:30pm. In addition, LONI will present its service strategy including current and future services so that the council members are equipped to fulfill their responsibilities as council members.

Cybersecurity Opportunity

As a follow-up from our ongoing conversations with Regents on this topic, the Commissioner requests the LMC provide a recommendation on an appropriate business model, funding model, and service model for LONI to assist its members with cybersecurity.

The Executive Director makes a motion to create an adhoc taskforce within the membership of the LMC made up of the Chair, Executive Director, Craig Woolley, Gene Fields, Gabriel Fagbeyiro, Eric Setz, and Dickie Howze with the goal of presenting a governance framework at the next meeting in August.

 - Type 1 Awards estimated at \$1M over 2 years
 - Type 2 Awards estimated at \$160M over 10 years
